#### **Covid-19 Risk Assessment for School Sites**

#### Introduction

We have carried out this risk assessment to ensure compliance with the Health & Safety at Work Etc. Act 1974, the Management of Health & Safety at Work Regulations 1999 and other associated legislation.

This Risk Assessment specifically relates to the risks associated with Covid-19 and is supplementary to existing Risk Assessments It follows the Health & Safety Executive Guidance 5 Steps to Risk Assessment. The 5 steps are as follows:

- Step 1: Identify the hazards.
- Step 2: Decide who might be harmed and how.
- Step 3: Evaluate the risks and decide on precautions.
- Step 4: Record your findings and implement them.
- Step 5: Review the risk assessment and update if necessary.

## **Scoring System**

### Four options for evaluating likelihood of harm (L) are used:

- 1. Very Unlikely
- 2. Unlikely
- 3. Likely
- 4. Very Likely

## When estimating potential severity of harm (S), three options are provided to choose from:

- 1. Slight harm
- 2. Moderate harm
- 3. Extreme harm

The impact of Covid-19 can vary enormously across individuals and is dependent on a significant number of other factors, including age, underlying health conditions and obesity. The overall mortality rate for the virus is now low. For this reason, the severity of most hazards has been considered moderate, except where pertaining to vulnerable or extremely vulnerable people where the severity has been rated as extreme.

To estimate the level of risk (**R**), the 2 factors are combined to determine risk as illustrated in the following table:

The risk level is entered in the R column as VL, L, M, H or VH.

Decisions on implementation of further action should be based on the following table:

Risk Level	Tolerability: Guidance on Necessary Action and Timescale
Very Low	Acceptable risk. No further action except to maintain existing control measures.
Low	No additional controls are required unless they can be implemented at very low cost (in terms of time, money and effort). Actions to further reduce these risks are assigned low priority. Arrangements should be made to ensure that the controls are maintained.

Medium	Consideration should be given as to whether the risks can be lowered, but the practicality and cost of additional risk reduction measures should be taken into account. The risk reduction measures should be implemented within a defined time period. Arrangements should be made to ensure that the controls are maintained, particularly if the risk levels are associated with harmful consequences.
High	Substantial efforts should be made to reduce the risk. Risk reduction measures should be implemented urgently within a defined time period and it might be necessary to consider suspending or restricting the activity, or to apply interim risk control measures, until this has been completed. Considerable resources might have to be allocated to additional control measures. Arrangements should be made to ensure that the controls are maintained, particularly if the risk levels are associated with harmful consequences.
Very High	These risks are unacceptable. Substantial improvements in risk controls are necessary, so that the risk is reduced to an acceptable level. The work activity should be halted until risk controls are implemented that reduces the risk so that it is no longer very high. If it is not possible to reduce risk the work should remain prohibited.
